Subject: UPWARD MOBILITY TO THE TEACHERS

Will the Under Secretary (SE-III), Government of the Punjab, School Education Department, please refer to his letter No.SO(SE.III)5-87/2014 dated 21.03.2014 on the subject noted above?

2. Matter was referred to Secretary (Regulations) for advice and that Department responded that Finance Department may determine whether it is a case of promotion or otherwise, if it is a promotion case, then it is actualized with immediate effect (copy enclosed).

3. According to Para 3(i) of School Education Department's notification No.SO(SE.III)2-16/2007 dated 06.11.2009, competent forum is District Selection Committee and not District Promotion Committee. Moreover, the matter was settled by District Selection Committee. Hence, it is not a promotion. Advice of Finance Department as mentioned in the reference was rendered in the cases of retired teachers; whereas, the lady teacher is serving in the Department. Attention is also drawn towards Para 3(vii) of School Education Department's notification No.SO(SE.III)2-16/2007 dated 06.11.2009, whereby it has been clarified that number of posts notified by EDO(Education) for each level as on 1st December of every year.

4. In view of the above, Administrative Department is advised to determine the fact whether she was entitled to grant of BS-15 in the year 2009 or otherwise. In case she fulfils all the conditions mentioned in the above referred policy letter, she may be considered for grant of higher scale as per policy.
